The African Food Regulatory Authorities Forum (AFRAF) was created by the African Union Commission (AUC), in partnership with the National Food Safety Authority (NFSA) of Egypt.

The inaugural meeting was organized in partnership with:

1. Background and Rationale

Food safety and nutrition are key determinants of health and human development. Food regulatory decisions have far-reaching implications on the health, agriculture and trade agendas of any given country, both domestically and at the international level.

Africa's contribution to the global food and agrifood supply is increasingly important, considering the important water and land resources afforded by the continent. African countries are demonstrating increasing commitment to modernizing and further enhancing their agricultural output and their food and agrifood production, with opportunities of development that can have important positive impacts on the economies of African countries and the continent.

Producing safe and nutritious food for Africa's population and increasing intra-regional trade of food and agrifood products within the African continent were also identified as some of the objectives pursued by the African Continental Free Trade Agreement (AfCFTA) launched in 2021.

In recent years, African leaders have prioritized actions in relation to food safety and SPS matters in an effort to address some of the public health and economic challenges. Several discussions have taken place on the possibility of establishing a unified food safety agency for the continent, sharing a common SPS policy framework and with the dual objectives of harmonizing SPS measures and supporting a common approach to food safety capacity building across the African continent.

Many changes are being witnessed in the African food safety regulatory context, with the development of new food competent authorities and agencies entrusted with the overall food safety regulatory mandate, such as the creation of the Food Safety and Quality Authority of the Gambia, the National Food Safety Agency of the Arab Republic of Egypt (NFSA) and similar agencies established in Nigeria, Ghana, and Mauritania.

These changes, along with efforts of coordination and food regulatory convergence led by African Regional Economic Communities (RECs), such as ECOWAS and EAC, would benefit from the creation of a favourable collaborative environment between African food regulators, through the development of an **African Food Regulatory Authorities Forum (AFRAF)**, under the leadership of the African Union Commission, its specialized departments and in partnership with the RECs.



This direction is further supported by the outputs of **36th Ordinary Session of the African Union Assembly of Heads of State and Government**, held on 18-19 February 2023 in Addis Ababa, Ethiopia identifying the priority of the year as being **"Accelerating the Implementation of the Africa Continental Free Trade Area"** and highlighting the importance of the food and agrifood sector in the intra-continental trade.

The potential for growth of this segment of intra-continental trade is estimated to be exponential and needs to be further driven by **enhanced alignment of African food regulatory frameworks, which requires the development of the relevant forum for Dialogue and collaboration between African Food Regulators.**

Recognizing that collaboration between food competent authorities is imperative to address an increasingly complex and interdependent health, food production and food trade environment, food competent authorities in Africa supported by international partners, decided to convene a network of African food competent authorities <u>at the heads of</u> <u>authority level</u>, with the aim to facilitate **engagement and discussions amongst leaders of African food regulatory authorities**.

This network will be known as the African Food Regulatory Authorities Forum or AFRAF.

2. Objectives of the AFRAF

The AFRAF aims to:

- Serve as an information exchange, experience sharing and collaboration development Forum, between food competent authorities of countries of the African Union, joining the Forum.
- Shape an agenda of collaborative initiatives to contribute to the development of a path forward for African food regulatory harmonization and integration as part of the implementation of the African Continental Free Trade Area (AfCFTA) and to address common challenges faced by African food competent authorities and the food and agrifood production sector.
- Contribute to the delivery of commitments of the Food Safety Strategy for Africa (FSSA)

 2022-2036, through supporting the operation of a science-based and efficient food
 regulatory environment in Africa leading to delivering *"safer agrifood value chains
 across the continent, reduced foodborne disease burden in Africa, improved*

competitiveness of Africa's food commodities for increased intra-African and global trade."

 Develop a foundation for the governance structure of the soon to be established African Food Safety Agency (AFSA).

3. Inaugural Meeting of AFRAF: Participants and Delegations

The first meeting of AFRAF gathered over 200 participants from the Arab Republic of Egypt, Africa and around the world:

- ✤ 55 participants from food regulatory agencies, representing 38 African countries.
- 10 participants representing the African Union Commission, Regional Economic Communities (RECs) and African Organizations.
- 20 participants from 6 organizations of the United Nations, working in areas pertaining to food safety ad food security, namely:
 - The United Nations Industrial Development Organization (UNIDO).
 - The Food and Agriculture Organization of the United Nations (FAO).
 - The World Health Organization (WHO).
 - The World Food Program (WFP).
 - The Standards and Trade Development Facility (STDF), hosted by the World Trade Organization (WTO).
- ✤ 8 non-African countries were represented at the Forum:
 - Australia.
 - Germany.
 - Lebanon.
 - The Netherlands.
 - The Sultanate of Oman.
 - Portugal.
 - The United Kingdom.
 - The United States of America (USA).



4. Key Interventions and Meeting Outputs

The meeting's opening Ceremony showcased an important level of mobilization with respect to country representatives and international organizations supporting the creation of the Forum, including cooperation from African food regulators. Some highlights include:

- Mr. Ali Badarneh, Chief of Food Security and Food Systems Unit at UNIDO expressed the need to use non-traditional regulatory approaches to address food safety and called on development partners and UN agencies to have a coordinated approach in supporting Africa regarding food safety reformation in the continent.
- Dr. Eva Al-Zein, Representative of the World Health Organization (WHO), recognized the public health impact of consuming unsafe food, stating that approximately 33 million years of life are lost due to consuming contaminated food. She called for modern regulatory approaches and structured management system(s) for enhanced food safety. She reminded the meeting of the Global Food Safety Strategy which exists and compliments the Africa Food Safety Strategy which should be implemented in the region.
- Mr. Melvin Spreij, Head of the Standards and Trade Development Facility (STDF), World Trade Organization (WTO), highlighted the need to develop enablers of safe food trade in Africa, which would contribute to protecting health, to stimulating economic development, to reducing poverty and to enhancing food security.
- Speaking on behalf of Ms. Kate Newton, Deputy Regional Director, Middle East, North-Africa and Eastern Europe, World Food Program (WFP), Mr. Fernando Ubarana (Food Safety and Quality Assurance Officer, WFP), emphasized the importance of addressing food safety for regional markets and of enhancing regional and intra-African procurement of safe food for global food programs.
- Mr. Abdul Hakim Elwaer, Assistant Director General and Regional Representative, Food and Agriculture Organization of the United Nations (FAO), recognized the efforts deployed by the African Union (AU) in addressing food safety through the AU's Partnership for Aflatoxin Control in Africa (PACA), the Food Safety Strategy for Africa and the SPS Strategy for Africa. He encouraged participants to propose recommendations that could be translated into initiatives for improving food safety in Africa and neighbouring regions.

Dr. José Emilio Esteban, Under Secretary for Food Safety, United States Department of Agriculture (USDA), recognized how the inaugural meeting of AFRAF was a unique opportunity to enhance collaboration in the region's food regulatory space. Dr. Esteban stressed the need to rely on 3 key principles that will contribute to enhancing food safety in Africa: (1) innovation - with the development of standards that "take us to the future"; (2) science - through establishing science-based regulations that help ensure food regulatory decisions are robust and transparent "in how data is collected and interpreted", and (3) accountability - in developing and implementing food regulatory decisions.

The two hosts of the AFRAF, Her Excellency Ambassador Josefa Sacko, the African Union Commissioner for Agriculture, Rural Development, Blue Economy, and Sustainable Environment (ARBE), and Dr. Tareq El-Houby, Chairman of the Board of the National Food Safety Agency (NFSA), Arab Republic of Egypt welcomed participants to the Forum and officially opened the inaugural meeting of AFRAF, with the following notable calls for action:

- The Forum be a key foundation of the food safety regulatory development pyramid in Africa, as stated by Dr. El-Houby.
- AFRAF be a vehicle of active transformation of food regulation in Africa by setting a course for future collaborative action, both within Africa and globally, helping to address food safety concerns.
- AFRAF acts as the General Assembly of the soon to be operationalized African Food Safety Agency (AFSA), as stated by Amb. Sacko.
- Take advantage of the opportunities outlined in the meeting agenda (<u>Annex 1</u>), to:
 - Take stock of priorities, challenges, and opportunities of food regulatory authorities in Africa, including the review of the AU Commission's efforts to bolster food safety interventions in the continent through various initiatives, such as the Food Safety Strategy for Africa and the creation of the African Food Safety Agency.
 - Deliberate on efforts of harmonization of food regulatory measures across the continent, particularly through the review of particular interventions being implemented by Regional Economic Communities, such as the Economic Community of West African States (ECOWAS).



- Share the perspectives of representatives of the agri-food sector on the food regulatory landscape, with the review of impediments to trade and avenues to alleviate such market access limitations for intra-African Trade.
- Identify capacity building needs and discuss opportunities to address these needs through collaboration with regional and international partners contributing to the discussions.
- Share modernized approaches to food control, such as the reliance on Voluntary Third-Party Assessments (vTPA) and the possible use of remote audit and certification frameworks as part of the development, modernization and deployment of food regulatory requirements in Africa, in a manner that supports improving riskbased inspection, targeting and optimization of food regulatory resources.
- Review lessons learnt and experiences of food regulators from other parts of the world, present at the forum, and discuss opportunities for future collaborations.
- Reiterate the commitment to the operationalization of the African Food Safety Agency, as a key component of the food safety governance structure in the continent.
- Develop a path forward for the operationalization of the African Food Regulatory
 Forum with the discussion of its proposed charter and conditions of operations.

A questionnaire (<u>Annex 2</u>) was developed to obtain feedback from participants in the forum on their expectations vis a vis AFRAF and how it can contribute to enhancing food regulatory cooperation in Africa.

Approximately 60% of registered participants responded to the survey representing 70% of African countries present at the meeting. These respondents represented food regulatory authorities that exercised their regulatory oversight as part of a single food agency system (33%) or as part of a multi-agency system (66%).

Respondents indicated that they expected AFRAF to:

- Strengthen food safety awareness amongst policy makers in African countries.
- Support networking and collaboration amongst African food regulators.
- Support discussions and recommendations related to policy development.
- Enable to share experiences between food regulatory authorities.



- Foster harmonization of food regulatory frameworks at the level of the African continent.
- Offer solutions to common challenges and issues related to food safety and regulations.

Respondents also commented on their expectations that the operationalization of the African Food Safety Agency will contribute to:

- Enhancing capacity building and training of food producers and regulatory bodies in Africa in areas related to food safety.
- Helping Africa align with global food safety standards and to streamline regulatory processes.
- Collaborating with other organizations and technical working groups within Africa.
- Identifying priorities, challenges and opportunities for food regulatory authorities to help resolve common food safety issues.
- Trade facilitation of food and agri-food products, within Africa and with international markets.

Finally, the meeting witnessed:

- The launch of the the voluntary Third Party Assurance (vTPA) Programme Assessment Tool, by UNIDO, a tool aimed to provide guidance to implement the Codex Guidelines on the use of vTPA, which will greatly benefit pilot projects in Mali, Rwanda, Senegal and Uganda.
- The signature of the Memorandum of Understanding between the FAO and the Arab Republic of Egypt, to implement assessment of the food control and plant protection systems through support of EU-funded SPS for Africa Project, being implemented by FAO and the African Union.



5. Conclusion of the Inaugural Meeting of the AFRAF and Next Steps:

African regulators present at the inaugural meeting of AFRAF:

- Adopted the Cairo "Declaration" establishing the Africa Food Regulatory Authorities Forum (<u>Annex 3</u>).
- Discussed initial input to a draft charter, aimed to support the governance of the membership and operations of the of the AFRAF and Agreed to further discuss this Charter until its adoption at a future virtual meeting of the AFRAF.
- Recommended to use the African Food Regulatory Authorities Forum (AFRAF) as an engine to foster the development of food regulatory cooperation between food regulators in Africa.
- Supported the operationalization of the Africa Food Safety Agency offering the scientific support and expert advice needed to existing SPS coordination mechanisms currently underway under the auspices of the Regional Economic Communities (RECs) of Africa.
- Requested the African Union Commission support Member States to fully operationalize AFRAF and AFSA without further delays.

ANNEX 3: The Cairo Declaration



High Level Senior Food Regulators Meeting of African Food Competent Authorities

The Cairo Declaration

Agreed in Cairo, 13 October 2023

Promoting Collaborative African Food Regulatory Frameworks to support the Implementation of the Food Safety Strategy for Africa 2022-36, and the Operationalization of the African Food Safety Agency (AFSA).

African countries are demonstrating increasing commitment to modernizing and further enhancing their agricultural output and their food and agrifood production, with opportunities of development that can have important positive impacts on the economies of African countries and the continent.

The potential for growth of intra-continental trade of food and agrifood products is estimated to be exponential and needs to be further driven by enhanced alignment of African food regulatory frameworks, which requires the development of the relevant forum for Dialogue and collaboration between African food regulators

The representatives of the African food regulatory authorities undersigned, with the leadership of the African Union Commission, and with the support of international partners, gathered at the inaugural meeting of the African Food Regulatory Authorities Forum (AFRAF), convened in Cairo, Arab Republic of Egypt from 11-13 October 2023:

Acknowledge the imperative of developing a sustainable mechanism of collaboration between food competent authorities in Africa, to address an increasingly complex and interdependent health, food production and food trade environment, and

Commit to create a network of African food competent authorities at the heads of authority level, known as the African Food Regulatory Authorities Forum or AFRAF with the aim to:

Serve as an information exchange, experience sharing and collaboration development Forum, between food competent authorities of member states of the African Union,

Shape an agenda of collaborative initiatives to contribute to the development of a path forward for African food regulatory harmonization and integration as part of the implementation of the African Continental Free Trade Area (AfCFTA) and to address common challenges faced by African food competent authorities and the food and agrifood production sector,

Contribute to the delivery of commitments of the Food Safety Strategy for Africa (FSSA) - 2022-2036, through supporting the operation of a science-based and efficient food regulatory environment in Africa,

Act as the General Assembly of the soon to be operationalized African Food Safety Agency (AFSA).

The Regulators gathered in Cairo, agreed to work towards the adoption of a Charter governing the membership and operations of the AFRAF and to use this mechanism as an engine to foster the development of food regulatory cooperation between food regulators in Africa, in a manner that supports the operationalization of AFSA and is complementary to SPS coordination efforts carried out under the auspices of the Regional Economic Communities (RECs) of Africa.
